Although these shares were allotted in dematerialized form, they are currently reflected under the 'physical' category, as the application for listing and trading approval was submitted on October 8, 2025subsequent to the receipt of corporate action confirmation from NSDL on October 6, 2025. Listing and trading approvals were granted by BSE and NSE on October 8, 2025, and the said shares were admitted for trading on both exchanges with effect from October 9, 2025.
